The Age Categories of riders will be as follows:

Pony Rider 0-16 (Must ride a pony)

Juniors 12 - 18

Adults 18 up

Heights of ponies.

1. All ponies registered as such as at 31st December 2014 (including those up to 1.50m) will be allowed to continue as a pony until they retire.
2. As from 1st Jan 2015 all new ponies registered must measure 1.48m without shoes and 1.49m with shoes upon **initial** registration. If measured during competition they may measure 1.50m without shoes and 1.51 with shoes.
3. No life height certificates will be issued.
4. Ponies who had a valid life height certificate as at 1st August 2012 will retain their life status until they retire.
5. All other ponies must be measured on an annual basis by the recognized SASJ measurers.

Registration

1. All competitors must be a member of a club, and SAEQA as at closing date of entries.
