PROMOTION MARKS ARE DETERMINED FROM TWO COMPONENTS:

1. SCHOOL BASED ASSESSMENTS (SBA)

SBA includes **ALL** formal assessment tasks set throughout the year prior to the commencement of the end-of-year examinations. A **COMPLETE** SBA record is one of the requirements for writing the end-of-year Examinations.

2. END-OF-YEAR EXAMINATIONS Entry to write END-OF-YEAR EXAMINATIONS depends on a complete SBA record for all subjects and an **ABSENTEE RATE OF LESS THAN 20 DAYS PER YEAR**.
